## **Points to Note:**

- 1. Frontline Personnel shall submit the Application Form to the Construction Industry Council (CIC) by mail.
- 2. Applying for withdrawal will be considered as your revocation of consent to participate in the Frontline Personnel Safety Performance Recording Scheme.
- 3. After receiving the Application Form, the CIC shall handle it within 14 calendar days.
- 4. Upon successful completion of the application, Project in Charge and Rating Staff will not be able to record the latest safety performance for Frontline Personnel on the platform of Frontline Personnel Safety Performance Recording Scheme (hereinafter referred to as "Platform").

5. The safety performance items previously recorded on the Platform in respect of the Frontline Personnel will be hidden and the records of the safety performance items will be automatically removed after 12 months. If Frontline Personnel rejoin the scheme, the safety performance records that have not yet expired will continue to be retained and displayed on the platform.
